

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to kathrynsogard.com, and KHUB Enterprise LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to KHUB Enterprise LLC include kathrynsogard.com. Collection of your Personal Information

In order to better provide you with products and services offered, KHUB Enterprise LLC may collect personally identifiable information, such as your:
